# **NBCC SaBA Week**

The third annual NBCC Safer Business Action Week (SaBA Week), took place in October with police and partners from across the country joining forces to tackle retail and business crime in their local communities.

All police forces in England and Wales, along with The Police Service of Northern Ireland, supported the national week of action and early results show that it has had a significant impact in disrupting and tackling prolific offender of shop theft and other business crime.

The NBCC are working with forces to collate the results, but with results of 18 forces so far, we know that between them there were 408 SaBA Days held involving over 2,750 officers and staff, with over 500 arrests made and thousands of businesses engaged.

With many forces who took part have yet to share their results, these numbers will increase significantly.





Here are some of the highlights so far:

#### **Greater Manchester Police:**

- 75 SaBA days
- 435 officers & staff
- 96 arrests, plus over 143 stop searches
- 308 store visits,
- 24 partnership meetings
- 56 crime reduction visits
- 49 offender disruption visits

GMP have several good news stories whereby prolific offenders were arrested and charged with numerous offences.

#### **Hampshire Police**

Police and crime commissioner (PCC), Donna Jones, announced the establishment of the Business Crime Partnership, aimed at reducing crime impacting businesses and the communities they serve.

#### **Cambridgeshire Constabulary**

- 276 businesses engaged with across the county.
- 'Wanted Wednesday' social media circulation in Cambridge of unidentified offenders

#### Sussex Police

During the week, response attended the call of a vehicle believed to be involved in an Organised Crime Gang targeting clothing stores. Recovered from the car was £2280.07 worth of clothing. A second car of five suspects was stopped and five arrested for theft offences interviewed and released on bail.

Following an alert from Waitrose, three were arrested for travelling across Brighton, Lewes and Wealden areas bulk shoplifting at national stores. S18 searches revealed a significant haul of stolen goods, drugs and £4000 cash seized from an address in Brighton.



#### **Metropolitan Police**

- Across the week they engaged with 1409 businesses
- Held 108 SaBA Days
- Involved 860 officers/staff
- Made 92 arrests.

NBCC lead Patrick Holdaway said: "A huge thank you to all the police, partners, PCCs, BCRPs and BIDs who supported SaBAWeek 2024. There has been so much activity taking place to tackle retail crime and business crime in local communities. A great team effort from all involved which demonstrates the joint commitment to tackle crime impacting our business communities."







#### NBCC on the road

their experiences of retail crime and the policing response.

On the **16th October** PCC Donna Jones chaired the inaugural Hampshire Business Partnership in Southampton, which later featured in her Police and Crime Plan.










The next day saw Patrick present to the Data & Analytics Practitioners Event where he presented in a new approach to data sharing with retailers.

The NBCC support a range of areas of business crime over and above retail, a good example of this is a meeting Patrick attended hosted by the tool manufacturers association on the **22nd Oct**, to discuss what more could be done to mitigate the theft of tools.

Later that day Patrick attended the **Institute of Couriers Awards** evening where he was honoured to be recognised for his work in developing police guidance to better identify courier crime.


